Terms of the Laptop Loan

Terms: Your laptop is the property of Plattsmouth Community Schools and although you may put or contain personal information on the laptop, it is the sole property of Plattsmouth Community Schools. You will comply at all times with Plattsmouth Community School's Student/Parent Laptop Handbook and the Technology/Internet Safety Policy 6800, incorporated herein by reference and made a part hereof for all purposes. Any failure to comply may terminate your rights of possession effective immediately and the District may repossess the property. Plattsmouth Community Schools does not assume any responsibility or liability for any information that you put on your laptop.

Title: Legal title to the property is in the District and shall at all times remain in the District and the State of Nebraska. Your right of possession and use is limited to and conditioned upon your full and complete compliance with this agreement and the Student/Parent Laptop Handbook.

Loss or Damage: If the property is damaged, lost, or stolen, you are responsible for the reasonable cost of repair or its current replacement value on the date of loss. Loss or theft of the property must be reported to the District by the next school day after the occurrence and a Police report must be filed.

Repossession: If you do not timely and fully comply with all terms of this Agreement and the Student/Parent Laptop Handbook, including the timely return of the property at our request, the District shall be entitled to declare you in default and come to your place of residence, or other location of the property, to take possession of the property.

Term of Agreement: Your right to use and possess the property terminates not later than the last day of the school year, unless earlier terminated by the District or upon withdrawal from the District.

Nebraska statutes 79-737 and 79-2,127 allow the District to obtain reimbursement from, or on behalf of, students for any damage to, loss of, or failure to return school property. Borrower acknowledges and agrees that Borrower's use of the District Property is a privilege and that by Borrower's agreement to the terms hereof, Borrower acknowledges Borrower's responsibility to protect and safeguard the District Property and to return the same in good condition and repair upon request by Plattsmouth Community Schools.

Please read this entire document to determine if this program is needed for you and your student's protection against damage and loss of the loaned computer equipment in your care. **This form must be completed and marked Yes or No before the computer will be provided to the student.**

Coverage and Benefit

This agreement covers the computer loaned to the student against all damage or loss over \$100.00. Accessories and damage valued less than \$100.00 are not covered. Coverage is 24 hours per day. Total value will be determined at the time of loss or damage. In no case shall the value be greater than \$1,004.26. In the event of damage or loss, this agreement will pay 75% (up to \$753.20) of the amount of damage or loss. You will be responsible for 25% (up to \$251) of the amount of damage or loss.

Effective and Expiration Dates

This coverage is effective from the date this request form and payment are received by the school through the date at which the computer is requested to be returned in good order to the school, either when the student un-enrolls from the school or no later than the last day of the school year.

Cost to Participate

The cost is \$35.00 per school year. Partial semesters are not refundable.

It is agreed and understood that:

- Participation is offered to all students.
- Participation is totally voluntary.
- A separate application will be needed for each computer covered.

This form must be completed and returned to your child's school before a notebook computer will be checked out to them.
